# **Navigating Lending Criteria for Foreign Nationals**

Due to the high volume of enquiries regarding foreign nationals on the helpdesk, this month's Criteria Corner will highlight common criteria points for these cases and showcase the criteria changes in the market as more Lenders alter their policies. With now over 40 Lenders considering lending to foreign nationals, each with differing policies on address history, LTV, credit files and visas, finding the right criteria to meet a client's needs can be challenging. #### **Acceptable Visas**

Many types of visas entitle a foreign national to reside in the UK, such as Skilled Worker, Ancestry, and Global Talent visas. A key point is that these visas all have a right to work in the UK, which is crucial for lending purposes.



#### **Lending Above 75% LTV**

While the Lenders listed will vary depending on the client's address history and LTV requirements, the following can consider above 75% LTV:

Barclays, Halifax, Skipton BS, Buckinghamshire BS, Cambridge BS, Generation Home, Mansfield BS, Mpowered, Principality BS, Darlington BS, Hinckley & Rugby BS and Nottingham BS\*.

\*Nottingham BS requires a 2-year credit file. However, this does not need to be from the UK, as they can source credit files from select overseas countries.

#### No Minimum Address History Requirements
